1) Public Comment

- a. Members of the public were given the opportunity to directly address the Committee on any item listed on the agenda.

- 2) Resolution of the Beverly Hills City Council Liaison / Rodeo Drive / Special Events / Holiday Program Committee authorizing public meetings to be held via teleconferencing pursuant to Government Code Section 54953(e) and making findings and determination regarding the same.
 - a. New legislation (AB 361) was recently adopted allowing the Beverly Hills City Council Liaison / Rodeo Drive / Special Events / Holiday program Committee to

continue virtual meetings during the COVID-19 declared emergency subject to certain conditions and the proposed resolution implements the necessary requirements.

Motion by Councilmember Lester Friedman, seconded by Mayor Bosse and approved unanimously.

- 3) Request for a Temporary Street Closure of the 400 Block of North Crescent Drive and Temporary Exemption of Municipal Code Relating to Landing of a Helicopter for "Beverly Hills Cop 4"
 - a. A temporary street closure of the 400 block of N. Crescent Drive on Saturday, September 24 from 8am 2pm for an administrative landing zone for a helicopter
 - b. To have a professional motion picture helicopter pilot conduct a precision flight maneuver on Crescent Courtyard of City Hall and hover for a precision flight scene under 500 feet
 - c. A temporary exemption of Beverly Hills Municipal Code 5-6-601 relating to the landing of a helicopter in the City.
 - The Liaisons are in support of the Request for Temporary Street Closure, Precision Flight Scene Filming, and Temporary Municipal Code Exemption for "Beverly Hills Cop 4".
- 4) Update Regarding 2022 Citywide Holiday Decor
 - The Liaisons approved the recommendations with the exception of the Gateway canopy light proposal, and they will move forward to the full City Council at the August 23, 2022 City Council Meeting for approval.
- 5) Proposal from the Rodeo Drive Committee Regarding the 2022 Rodeo Drive Holiday Lighting Celebration (November 17, 2022) and the Rodeo Drive Holiday Decor Plan
 - The Liaisons approve the recommendations with alterations and the item will be brought forward to the August 23rd Study Session for full City Council approval.
- 6) Discuss Community Services Holiday Programming and Events, including Holidays at Greystone Mansion and Gardens on December 3-4, 2022
 - City Staff will bring the recommendation forward as part of a consolidated Citywide Holidays report to the full City Council at the August 23, 2022 City Council Meeting.
