**INTRODUCTION** 

The Arts and Culture Commission conducted a Fine Art Priority Exercise on May 16, 2022 and selected the sculpture *Trinity* by Judy Chicago for acquisition and recommendation to City Council.

The Council Liaisons on August 24, 2022 supported this acquisition and recommended the southwest corner in front of Crescent Dr. garage elevator structure in City Hall as the preferred location for installation.

Staff will present updated information related to this proposed fine art acquisition and corresponding installation.

#### DISCUSSION

On November 18, 2022 Judy Chicago joined City staff for a site visit. The artist agreed with the Council Liaisons recommended installation site in City Hall. The artist placed mock-ups of the sculpture on City site with her desired orientation for the artwork.

Two significant changes were identified at the time of the artist's visit in November 2022:

• Requirement to install the artwork on a concrete base to ensure longevity and protection of the artwork, instead of installing the artwork flushed to the grass. The artist

has selected Musky Mulberry as the color to be used for the concrete base to complement the artwork.

• Preference for the alternative location at Beverly Gardens Park (BGP) to be the Canon Block, instead of the Rodeo Block.

Since these two significant changes deviate from the original information that was reviewed by the CC/ACC Liaisons in August 24, 2022, it is necessary to bring the updated proposed information to the CC/ACC Liaisons for their additional review and approval.

Subsequently, on December 20, 2022 the Recreation and Parks Commission approved the Beverly Gardens Park, Canon block as secondary location for the installation of the Judy Chicago artwork, should the City Hall location not work out.

To ensure longevity and success for outdoor art installations, it is required to install the artwork on a concrete platform. Staff suggested for the base to be constructed on integral color concrete to ensure that if in the future the concrete base suffers chipping, the color would carry throughout the base and be less noticeable. The artist has selected Sika Musky Mulberry as the color to be used for the concrete base to complement the artwork. Staff will bring physical sample of the proposed palette color for the Liaisons review.

The purchase price of the artwork is \$450,000, but Jeffrey Deitch Art Gallery has offered a discount (approximately 11%) towards the City's acquisition of the artwork, leaving the City with a \$400,000 balance toward purchase of the piece. Staff has worked with Public Works staff including the City Architect and engineers to determine final costs of this installation and a 20% contingency. The Arts and Culture Commission approved at their March 14, 2023 meeting the "all in" cost of the acquisition of *Trinity* by Judy Chicago to be increased to \$550,000, to account for the purchase of the artwork, transportation, design and fabrication of the preferred anchoring system (that will allow for the artwork to be de-install for future conservation efforts without impact to the concrete base), fabrication of the integral concrete colored base, engineering, inspections, permits, landscaping and lighting.

#### **FISCAL IMPACT**

The funding for acquisition of the artwork is available in the Fine Art Fund, a restricted fund that can only be used for fine art related expenses. The current balance in the Fine Art Fund is approximately \$1.6 million dollars with \$700,000 available for artwork acquisition/installation through the Arts and Culture Commission Fine Art Priority Exercise process. The "all in" cost of the acquisition and installation of *Trinity* by Judy Chicago is not to exceed \$550,000.

#### RECOMMENDATION

The Arts and Culture Commission and City staff recommend Arts and Culture Council Liaison support of the updated information for the acquisition and installation of *Trinity* by Judy Chicago and recommend the southwest corner in front of Crescent Dr. garage elevator structure in City Hall as the preferred location for installation.

#### INTRODUCTION

The Arts and Culture Commission and City staff recommend the acquisition of the artwork, *Trinity*, by world-renowned artist Judy Chicago.

#### DISCUSSION

As a part of the Arts and Culture Commission's Priority Exercise, held at their meeting on May 10, 2022, the Commissioners submitted fine artwork for acquisition by the City as part of the City's Fine Art collection. A total of 5 submissions were received and the Arts and Culture Commission reviewed and recommended the selection of a seminal piece by artist Judy Chicago for acquisition.

Judy Chicago is among the world's most influential women artist of the 20<sup>th</sup> Century. For over five decades, Judy Chicago has remained steadfast in her commitment to the power of the arts as a vehicle for intellectual transformation and social change, and to cause of women's equality including the right to engage in the highest level of art production. Her full biography is included in Attachment 1. The proposed artwork is a part of an exclusive edition of 3, with only one piece available for purchase as the other two editions are an artist proof and a foundation proof that the artist's foundation will retain.

The proposed piece, *Trinity*, is being offered to the City by the Jeffrey Deitch Gallery in New York and is constructed out of Matthews polyurethane paint on stainless steel and measures 64 x 127 x 60 inches.

City staff and Arts and Culture Commissioners have provided the top two proposed locations for Liaison review, please see renderings of the piece at these location in Attachment #2. Of these two locations, Commissioners, staff and the artist representatives unanimously agree that the preferred location is the southwest corner in front of the Crescent Dr. garage elevator structure in City Hall. Should the Council Liaisons support acquisition of the piece, City staff will prepare a presentation for the full City Council to consider its purchase and authorized use of the Fine Art Fund for its acquisition in the amount of \$400,000, and for the costs of shipping, installation, fabrication of the base, with a 20% contingency. Should the Council Liaisons recommend its acquisition, City staff would finalize negotiations with the Jeffrey Deitch Gallery and the artist for acquisition of the piece, and complete work on the purchase agreement. Staff will return to City Council for approval of the agreement with Jeffrey Deitch once finalized.

#### **FISCAL IMPACT**

The purchase price of the piece is \$450,000, but Jeffrey Deitch Art Gallery has offered a discount (approximately 11%) towards the City's acquisition of the artwork, leaving the City with a \$400,000 balance toward purchase of the piece. Acquisition of the piece will also include shipping, installation, fabrication of the base, and a 20% contingency. Should the piece be recommended by the Liaisons to the Council, Community Services will work with Public Works staff including the City Architect and engineers to determine final costs of this installation. The funding for acquisition of the artwork would come out of the Fine Art Fund, a restricted fund that can only be used for fine art related expenses. The Fine Art Fund is financially supported through the City's Fine Arts Ordinance which is tied to commercial development upon facades in the City. Developers can either elect to incorporate artwork into their project or pay an in-lieu fee which contributes monies into the Fine Art Fund. As a result of this process, no public funds are utilized toward the purchase of artwork in the City's Fine Arts Collection. The current balance in the Fine Art Fund is approximately \$1.6 million dollars with \$700,000 available for artwork acquisition through the Arts and Culture Commission Fine Art Priority Exercise process.

#### **RECOMMENDATION**

The Arts and Culture Commission and City staff recommend Arts and Culture Council Liaison support acquisition of *Trinity* by Judy Chicago and recommend the purchase of this incredible artwork by the City Council and placement at the recommended location. In a moment when the rights of women to control their own bodies is imperil in our country, this important art acquisition sends a signal that the City of Beverly Hills stands resilient in its support of female self-determination by prominently displaying a seminal piece by one of the most iconic and celebrated feminist artists in the world.

The Arts and Culture Commission is being asked to consider the presented updated information for the installation of the sculpture titled *Trinity* by artist Judy Chicago. This sculpture was selected and recommended for acquisition at the 2022 Fine Art Priority Exercise by the Arts and Culture Commission, and it will be presented to the City Council/Arts and Culture Liaison for consideration at their March 23, 2023 meeting.

The Arts and Culture Council Liaisons had previously reviewed this proposed fine art acquisition at their August 24, 2022 meeting, and they had recommended at that time the southwest corner in front of Crescent Dr. garage elevator structure in City Hall as the preferred location for installation of this sculpture.

On November 18, 2022 the artist of this sculpture, Judy Chicago, joined City staff for a site visit. The artist agreed with the Arts and Culture Council Liaisons recommendation to install the sculpture *Trinity* at the selected site in City Hall. The artist also identified an alternative location for installation at Beverly Gardens Park – Canon Block. During this visit the artist placed the mock-up of the sculpture on both sites with her desired orientation.

Two significant changes were identified at the time of the artist's visit in November 2022:

- Requirement to install the artwork on a concrete base to ensure longevity and protection of the artwork, instead of installing the artwork flushed to the grass. The artist has selected Musky Mulberry as the color to be used for the concrete base to complement the artwork.
- Preference for the alternative location at Beverly Gardens Park (BGP) to be the Canon Block, instead of the Rodeo Block.

Since these two significant changes deviate from the original information that was reviewed by the CC/ACC Liaisons in August 24, 2022, it is necessary to bring the updated proposed information to the CC/ACC Liaisons for their additional review and approval.

March 23, 2023 has been confirmed for this upcoming CC/ACC Liaison meeting. The Fine Art/Public Art Ad Hoc Committee will represent the ACC at this meeting.

We are including as attachment the PowerPoint presentation with the updated information for your review.

Staff is seeking approval of the proposed updated installation information, and also approval to increase the amount that was allocated through the Fine Art Priority Exercise process in May 2022 for the "all in" cost of the acquisition of *Trinity* by Judy Chicago, from the originally approved amount of \$500,00 to \$550,000, to account for inflation and the recommended integral concrete colored base.

Staff, the Artist, and the City's Art Conservators agreed that to ensure longevity and success for this outdoor art installation, it would be beneficial to install the artwork on a concrete platform.



### **City Process Approval**

Two significant changes were identified at the time of the artist's visit in November 2022:

- Preference to install the artwork on a concrete base to ensure longevity and protection of the artwork, instead of installing the artwork flushed to the grass.
- Preference for the alternative location at Beverly Gardens Park (BGP) to be the Canon Block, instead of the Rodeo Block.

Since these two elements deviate from the original proposal information that the CC/ACC Liaisons reviewed back in August 24, 2023, it is necessary to bring the updated proposed information to the CC/ACC Liaisons for their additional review and approval.

The date of this upcoming CC/ACC Liaison meeting has been confirmed for March 23, 2023. The Fine Art/Public Art Ad Hoc Committee will represent the ACC at this meeting.






### **City Hall Location- Map**






### **City Hall -Plan**




### **BGP Rodeo Block- Former Map**







### **BGP Canon Block- Updated Map**









### **BGP Canon Block- Plan**
